Meeting called to order and Mr. Newton welcomed everyone. This electronic meeting is being recorded as well as minutes taken.

## **Approval of Minutes:**

Mr. Trayer made a motion to approve the minutes of January 24, 2020 and February 25, 2020. Mr. Propst seconded the motion. **Approval was unanimous**.

#### Covid 19 Update:

Mr. Newton presented an update on MRRJ actions in response to Covid 19. At this time there are no substantive changes. There are several expenditures which are being tracked. The jail has applied for both FEMA and VDEM grants. When approved will submit expenditures for reimbursement.

Ms. Whetzel discussed CARE Act funding. This may be an option to cover some of the costs incurred.

### FY '21 Budget Summary:

Ms. Colvin presented the FY 2021 budget summary. There have been several revisions since March 2020. The inmate count is down to 700. There was no change to bed rentals. Revenue and expenditure changes discussed. Mr. Newton anticipates that there will be a gradual increase in inmate population over the next several months. The FY 2021 budget is based on 895 inmates. Some of the courts may consider using HEM instead of jail. Ms. Colvin plans to proceed and will have the budget ready for approval at the June 23, 2020 meeting.

#### FY 2020 Closeout:

Ms. Colvin is working on a budget amendment. Pharmacy and Anthem costs are fluctuating. At this time maintenance and medical costs are both being estimated. Bed rental funds that were not used are being used to cover some of the expenditures. The amendment will also need to be approved at the June 23, 2020 meeting.

Ms. Colvin stated that the debt ratio needed to be met. The intent of the budget amendment is to comply with the debt ratio requirement. Ms. Colvin recommended that the Finance Committee meet one more time before the scheduled Board Meeting to provide staff with additional time to refine the year-end FY 2020 Budget Amendment.

When asked if there was a deadline to bill localities Ms. Colvin stated the deadline is August 15, 2020.
