Meeting called to order and Mr. Newton welcomed everyone.

Approval of Minutes:

Ms. Davidson made a motion to approve the minutes of September 15, 2020. Mr. Trayer seconded the motion. **Approval was unanimous.**

Jail Expansion Plan Update:

Mr. Newton updated the Finance Committee on the Jail Expansion Plan. Ms. Colvin reviewed the budget implications due to expansion:

- Discussed Board decision timeline.
- Construction Option decision will need to be made at the February 2021 Board meeting.
- Architect contract will be on the April 2021 Board meeting agenda for approval.
- How to proceed with borrowing constructions funds would need to be made at the April 2021 Board meeting in anticipation to proceed to borrow money July, 2021.
- Brief discussion of debt payments.
- A detailed cost analysis will be presented at the December Board meeting.

FY 2021 Budget Update:

Compensation Board - \$376,481 (18 additional emergency positions added effective November 1, 2020).

Comp Board Revenue	\$329,420
18 New Positions Cost	\$551,235
Net Local Cost	\$221,815

The Compensation Board providing a \$500 stipend effective December 1, 2020 for sworn officers only was discussed. Since the Board approved a previous stipend for all MRRJ Staff Superintendent Newton requested to bring the issue to the Board at the December meeting.

MRRJ is seeing rising medical and overtime costs due to a inmate hospitalizations. Specifically, MRRJ had an inmate eligible for transfer to VADOC that needed surgery. MRRJ requested VADOC transfer the inmate prior to surgery; VADOC did not. The inmate was hospitalized for a number of weeks post-surgery at the UVA Medical Center. This hospitalization required two staff all on overtime. Overtime is not an eligible reimbursable expense for state responsible inmates. Superintendent Newton intends to submit a bill for the overtime to VADOC considering the unique circumstances.

MRRJ is also seeing the number of female inmates rising.

FY 2020 Audit:

The Annual Financial Audit has been completed and PB Mares will present the audit results at the December Board meeting.

Staunton Work Crew and Van:

There has been no billing for this FY 2021 Budget item. At this time MRRJ does not have an Officer available due to vacancies and COVID-19.

Coronavirus Update:

\$163,517.00 of the \$182,055 previously approve CARES ACT money has been obligated.


FY 2022 Budget:

The Finance Committee is scheduled to meet January 22, 2021 at 2:00 p.m. to review the draft FY 2022 Budget. MRRJ is anticipating a decrease in Compensation Board per diem due to recent Criminal Justice Reform approved in the Special Legislative Session, Fall 2020.

Compensation Board employees are anticipated to receive a onetime 1.5% bonus on September 1, 2021.

With nothing further to discuss Mr. Trayer made a motion to adjourn. Ms. Davidson seconded the motion. Approval was **unanimous**.
