Meeting called to order and Mr. Newton welcomed everyone.

#### Risk Management:

At the request of a Finance committee member, Mr. Newton presented a PowerPoint presentation Concerning MRRJ risk management. All budget recommendations/decisions made by the facility staff were made considering these underlying risk management concerns:

- The need to increase physician/dental provider hours.
- . The need to improve the timeliness of medical clearance of new offenders at MRRJ.
- · MRRJ should have two (2) Officers on every transport.
- Facility age; core functions are becoming an issue. Current staff are not able to respond.

#### **Budget Options:**

All budget items cap inmate housing at 895 inmates. FY 2021 budget increases were broken down as follows:

- Allocation of 5.8% will only maintain the status quo. Does not address any risk management concerns.
- Allocation of 6.7% only adds pay increase January 1, 2021. Does not address any risk management concerns.
- Allocation of 8.5% provides for four (4) additional nurses, one (1) additional officer for transporting
  offenders, and one (1) additional maintenance employee. This option addresses a number of the
  high priority risk management concerns.
- Allocation of 16.5% plans for the future. I This option addresses a number of high priority risk management concerns. This option provides for needed increases in pharmacy, repair and maintenance, training, etc.

## Virginia Legislature

Possible legislation advances that could have an impact on the budget are:

- Salary increase unknown at this time.
- Providing an ID card to each inmate when discharged; unfunded mandate.
- Behavioral Health Standards (at present time the minimum jail standards do not provide any Medical or Mental Health standard other than the need for a physician.) While these proposed standards are not anticipated to impact the FY 2021 Budget, if approved they will substantively impact future budgets.

## Committee Discussion:

The committee directed staff to prepare the 8.58% option as the most viable option for FY 2021.

- FY 2021 budget anticipates an increase of 10.8% for health insurance
- 4 nurses approved (2 for July 1, 2020 and 2 for January 1, 2021)
- 1 Maintenance employee July 1, 2020
- 1 Transportation officer July 1, 2020
- 2% raise for staff January 1, 2021
